**ADMISSIONS POLICY 2017-18**

Water Street School has a Local Authority accepted maximum admission limit of 30 pupils per year group. Any parents considering sending a child to the school should make an appointment through the school office with the Headteacher. Arrangements can then be made for parents and the child to look around the school.

All parents of children starting this school for the first time are asked to complete an admission preference form administered by North Yorkshire County Council. In this form they must state clearly that Water Street Primary School is one of your preferences. Wherever possible, the Local Authority will meet parental preferences, unless to do so "would prejudice the provision of efficient education or the efficient use of resources" [Education Act 1996]

The Local Authority (North Yorkshire County Council) will allocate places as follows:

- **first** to children with an Educational Health Care Plan which names the school
- **second** to children and young people in Public Care for whom the school has been expressed as a preference
- **third** to children the Local Authority believe have special social or medical reasons for admission
- **fourth** to children within the normal catchment area of the school who have listed it as a preference
- **fifth** to children outside the normal area of the school who have listed it as a preference

For the first year of formal education, children are admitted at the start of the school year in which their fifth birthday falls. The school notifies parents in advance of the annual New Parents' Evening. This is an informal occasion where parents meet the staff and are given an insight into the experiences which their child will have at our school. It is also a chance for parents to discuss any anxieties or concerns they may have. Each child visits the school for short sessions before their September start. Staff will also visit new pupil's nursery settings and also make home visits.

If a child wishes to be admitted to the school, once their formal education has commenced, and providing their year group has not

reached its maximum admission limit, the school will automatically give the child a place-even if he/she lives outside the normal area of the school.

If the maximum admission limit has been reached, the Governing Body of the school has agreed that the class sizes in Key Stage 2 (children aged 7 – 11) may increase providing the school has sustained teaching assistant support for a reasonable percentage of the week. All parents will be referred to the Local Authority who may admit in catchment pupils after contacting the school. Out of catchment parents will be told that the year group limit has been reached and refused a place for their child. Both in and out of catchment parents have the right to appeal the Local Authority decision.

The school follows Department for Education guidance and legislation restricting KS1 class sizes to a maximum of 30 pupils.

The school is obliged to keep an admissions register which will contain the following pupil information:

- name in full
- sex
- name and address of parents. If both parents are not living with the child, then the school must make reasonable effort to obtain the address and telephone number of the absent parent.
- day, month and year of birth
- day, month and year of admission
- each pupils' Unique Pupil Number [UPN]
- name and address of school last attended if any

This information will usually be gathered from a child's parents at the pre-entry interview with the reception class teacher or through completion of the school registration form.

Deletion from the Admissions Register is allowed when:

- a school attendance order naming the school has been altered
- a pupil has been registered at another school
- a pupil is receiving full time education out of school
- he/she has moved to another area
- health has deemed the child legally exempt
- the child has been continuously absent for 4 weeks and after reasonable inquiry there is no information concerning the absence

Dual registration is permitted if a child is attending a special school on a part time basis, or temporarily receiving education in a hospital unit.
